

Privacy Disclaimer for application in SIGHTSoHO training activities

(Updated pursuant to EU Regulation 2016/679)

The ISS (Istituto Superiore di Sanità), with registered office in Viale Regina Elena 299, 00161, Rome, as Data Controller informs, pursuant to Articles 13 and 14 of the EU Regulation 2016/679 (hereinafter "GDPR"), that the data will be used within the EU funded Service Contract HADEA/2022/OP/0018 - *Training and networking of Substances of Human Origin (SoHO) Competent Authorities' staff for oversight* - for the following purposes and that the aforementioned data will be processed as follows:

1. Purpose and Legal Basis of Data Processing

The **processing** of personal data (listed in paragraph 3) is collected for the specific purposes related to the application in the SIGHTSoHO training activities as for the above-mentioned Service Contract.

The **Legal Basis** for the processing of personal data is found in Article 6(1)(a) of the GDPR, as "*the data subject has given consent to the processing of his or her personal data for one or more specific purposes (...)*".

2. Recipients to which the personal data are disclosed

Personal Data will be disclosed to Zadig ltd, for the purpose of the registration and log-in to the SIGHTSoHO web-based platform in order to join SIGHTSoHO training activities.

3. Categories of the personal data

For the purposes referred to in paragraph n.1, the treatment will be subject to the following categories of personal data:

- Full name;
- Email address;
- English Language level;
- Institution information (current function, city, country);
- Field of competence;
- Image recorded during synchronous live sessions.

4. Processing Methods

The processing of personal data is carried out as indicated in art. 4, par. 1, no. 2 GDPR and more precisely: collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction; The data processing will take place only with methods, tools and computer/digital procedures strictly necessary to achieve the purposes described in paragraph n. 1 of this privacy disclaimer.

5. Data Storage

Personal data will be stored until 5 years after the end of the Service Contract. Subsequently, the data will be deleted.

6. Rights of the data subject

The subject data has the rights referred to in art. 15-21 GDPR , more precisely the right to access, the right to rectify, the right to erasure, the right to restrict data processing, the right to data portability, the right to object, as well as the right to lodge a complaint with the Supervisory Authority (art. 77 GDPR and 141 Privacy Code, as amended by Legislative Decree 101/2018).

However, such withdrawal shall not affect the lawfulness of the processing carried out on the basis of the consent previously given, and it shall have the sole effect of ceasing to process the personal data of the data person for the future.

7. Exercise of rights

At any time, the data subject may exercise his/her rights by sending a communication to the ISS at the e-mail and PEC addresses indicated in point 8 of this privacy disclaimer, or by sending a request by registered letter to the institutional address of Viale Regina Elena 299, 00161, Rome.
